Softballife Hitting Clinic with Dan Nessler

We are excited to partner with Dan Nessler of Softballife to bring you a top notch hitting clinic on Saturday February 11th, 2017 at Valley High School. The clinic will be from 11:00-1:30.

Dan Nessler is the man behind Softballife, a Hall of Fame fastpitch player and coach with over 30 years of fastpitch playing and coaching experience at the highest level. Coach Nessler was inducted into the International Softball Congress (ISC) Hall of Fame in 2009, he's a 4-time ISC All-World performer, a 3-time ISC Team Champion, ASA/USA Softball Major Champion, 3-time ASA/USA Softball Major runner-up all with Penn Corp from Sioux City, IA. He was also an ASA/USA Softball Class A National Champion with Happy Chef from Mankato, MN. Coach Nessler was a 4-time participant in the US Olympic Festival Fastpitch Softball Series, 2-time ASA/USA 18U Boys National Champion Coach and is currently the ASA/USA Softball Assistant Coach for the 19U Junior Olympic Men's National Fastpitch team. Coach Nessler created Softballife in November of 2013, in which he dedicates his time to producing and posting instructional videos, tools and motivational quotes online and in social media all pertaining to fastpitch softball. Softballife already has well over 20,000 followers on Facebook.

Coach Nessler has been a fixture in our Minnesota fastpitch community since his playing days, doing clinics and private lessons. He is an advocate of the game and has dedicated much of his free time to giving back to players in the community. Coach Nessler has worked with countless high level athletes in his coaching tenure in our fastpitch community. He is a decorated player and coach and we very much look forward to bringing his hitting expertise to Strike Zone Sports.

Coach Nessler takes an individualized approach to hitting mechanics. As a hitter himself, he understands that the swing is unique to each player, so he first analyzes what each player does before making adjustments. He does not believe in a "cookie cutter" approach to the swing. Instead, Coach Nessler works with each player to understand their natural swing and make it as fundamentally sound as possible. He really excels at and enjoys helping hitters to understand the mental approach in the box and the importance of situational hitting so that each player can succeed at being the most productive they can be!

The format of this clinic will be extremely beneficial to participants. All participants will receive Coach Nessler's Hitting DVD (\$49.95 retail value) as a take home from the clinic and we will use it as a tool throughout the clinic itself. That way, when you get home to watch it, you'll know from hands on experience in the clinic with Coach Nessler how to execute all the skills. The mental approach to hitting will also be addressed, this is something very under instructed in camps and clinics elsewhere!!
